"At that point they thought, 'You're under a lot of stress,' so they referred me to a psychologist," said Alison. She tried therapy for a few months, but her therapist determined Alison's pain wasn't consistent with stress.

After arriving home one day doubled over with pain that had persisted the entire day, Alison's husband took her to the hospital. An internal ultrasound revealed a cyst on her ovary, and the emergency room doctor concluded this was the cause of her pain. Alison was sent home with pain medication and was told the cyst would rupture, resolving her issues.

However, the cyst never ruptured and she began to rely on up to eight codeine tablets a day to cope. As she continued to miss work, her doctor referred her to a gynecologist who recommended a monthly regimen of injections to stop her cycle, essentially putting Alison into early menopause.

After three rounds, Alison said she had "nausea, fatigue, dizziness and sweating" and was missing even more work. Now taking up to 10 codeine tablets a day, she decided to stop the injections. She was at a loss.

Alison decided to contact Best Doctors. Working in employee benefits, Alison was familiar with the service and knew she had free access to it through her employer.

Alison underwent a partial hysterectomy to remove her uterus and one of her ovaries. She had been cautioned that there was a chance the endometriosis could return, which it did. One year later she had the other ovary and her cervix removed.

The second procedure finally resolved her pain and she's been fine ever since. "It had been hard to diagnose and it took a long time—about seven years," she said. "It was peace of mind to finally have guidance that was in the right direction."
